INTRODUCTION:

Being healthy is necessary to all than wealthy for their well-being. Nobody ever afford to be unhealthy. Good health required good economic and social development (WHO 2000).

Sustainable health financing is a big challenge globally especially to developing country like Malaysia.

Currently, Malaysia's health care cost mostly are bourned by the the government through tax. However, since past two decades, there was flourishing of private healthcare. This leads to an escalation of health care cost national wide. The poor, the minorities and the people who are unable to pay suffer the most.

In May 2005, the World Health Assembly passed a policy resolution for the World Health Organization (WHO) whereby WHO would use Social Health Insurance (SHI) or National Health Financing Scheme (NHFS) as the strategy for mobilizing more resources for health, pooling risk, providing more equitable access to health care for the poor, and delivering better quality health care (WHO 2005)

National Health Financing Scheme (NHFS) as a way to mobilize revenues for health, pooling risk, enhances health sector's performance and provides universal coverage. Mobilized funds should be allocated to the poor and near poor population to improve their financial access to health care. How to design and implement NHFS have been largely based on each country capabilities.

Thailand, Indonesia, Philippines and Vietnam are our neighbour countries that already implement SHI/NHFS. They have lots of experiences in handling issues and challenges in implementation on SHI/NHFS.

OBJECTIVES:

In regards to the above issues, the conference aims to:

1. To invite health care experts, professionals and all healthcare providers to a common platform to discuss, elaborate, and deliberate on mobilizing community resources for SHI/ NHFS.
2. To invite international experts to share their experience in implementing SHI/NHFS.
